Chairman Farley presided and called the meeting to order at 5:30 p.m. with all members being present at that time.

MINUTES:

"Commissioner J. Phillips moved, seconded by Commissioner Shafer, to approve the minutes of the last meeting. This motion passed unanimously by acclamation."

SHERIFF'S DEPARTMENT REPORT:

Virgil Gammon provided the line item report for the use and information of the Committee. Following discussion,

"Commissioner Stevens moved, seconded by Commissioner Peay, to approve the Sheriff's Department report as presented. This motion passed unanimously by acclamation."

Commissioner Peay inquired as to the information to be provided by the Sheriff's Department in response to the comment at the Budget Committee public hearing regarding the dry cleaning of uniforms. Mr. Gammon advised they were working on the information for presentation at the next Budget Committee meeting and advised the Sheriff's Department had been involved in a Federal lawsuit because one of the SROs that made an arrest was not in a uniform that was clearly a Sheriff's Department uniform.

Commissioner J. Phillips asked about the 14/15 budget presented earlier and whether the salary changes regarding deputies had been implemented by the Budget Committee and was advised the requested changes had not been implemented and the Sheriff had accepted the Mayor's recommended budget.

EMERGENCY MANAGEMENT AGENCY REPORT:

Chairman Farley presented the written Emergency Management Agency report for the use and information of the Committee. Following discussion,

"Commissioner J. Phillips moved, seconded by Commissioner T. Phillips, to approve the Emergency Management Agency report as presented. This motion passed unanimously by acclamation."

OSHA REPORT:

Dan Goode presented the OSHA report for the use and information of the Committee. Following discussion,

"Commissioner Shafer moved, seconded by Commissioner Young, to approve the OSHA report as presented. This motion passed unanimously by acclamation."

Mr. Goode next provided the report on the recent TOSHA inspection of the Maintenance Department and PAWS advising the Maintenance Department received three citations and PAWS received one.

All violations have been corrected and no fines were issued.

CORRECTIONAL WORK CENTER REPORT:

Bernard Salandy presented the Correctional Work Center report for the use and information of the Committee. Following discussion,

"Commissioner Peay moved, seconded by Commissioner T. Phillips, to approve the Correctional Work Center report as presented. This motion passed unanimously by acclamation."

Mr. Salandy next presented a proposed budget amendment to provide sufficient funds to purchase an oven for the Workhouse as the old one is beyond repair.

JUVENILE DETENTION REPORT:

Lynn Duke presented the Juvenile Detention report for the use and information of the Committee. Following discussion,

"Commissioner J. Phillips moved, seconded by Commissioner Peay, to approve the Juvenile Detention report as presented. This motion passed unanimously by acclamation."

DRUG COURT REPORT:

No one was present for the Drug Court report.

PAWS REPORT:

Michael Gregory presented the PAWS report for the use and information of the Committee. Following discussion,

"Commissioner T. Phillips moved, seconded by Commissioner Stevens, to approve the PAWS report as presented. This motion passed unanimously by acclamation."

Mr. Gregory next presented proposed budget amendments to provide additional funds for overtime for employees and for gasoline for the remainder of the year. Following discussion,

"Commissioner J. Phillips moved, seconded by Commissioner T. Phillips, to approve the budget transfer for PAWS as requested. This motion passed unanimously by roll call vote."

Mr. Gregory next presented a proposed Grant Contract with the State of Tennessee, Department of Health in the amount of \$3,900 for low cost spay and neuter procedures with funding from the Animal Friendly car tags. Following discussion,

"Commissioner Shafer moved, seconded by Commissioner Peay, to approve applying for said Grant Contract with the State of Tennessee, Department of Health in the amount of \$3,900 and authorization of execution if received and to forward the same to the Budget Committee. This motion passed unanimously by acclamation."

AMBULANCE SERVICE REPORT:

Mike Nunley presented the Ambulance Service report for the use and information of the Committee. Following discussion,

"Commissioner Peay moved, seconded by Commissioner J. Phillips, to approve the Ambulance Service report as presented. This motion passed unanimously by acclamation."

Mr. Nunley next presented a proposed Agreement with the City of Murfreesboro for the conduct and coordination of an emergency medical first responder program advising the contract provides for the City of Murfreesboro responders to be credentialized by the Ambulance Service. Following discussion,

"Commissioner Peay moved, seconded by Commissioner J. Phillips, to approve the Agreement with the City of Murfreesboro and authorize execution of the same. This motion passed unanimously by roll call vote."

COUNTY FIRE/RESCUE REPORT:

Larry Farley presented the County Fire/Rescue report for the use and information of the Committee advising no one was hurt seriously in the recent incident where the tanker overturned in route to a fire. The apparatus was a loss and was a volunteer fire department vehicle. Chief Farley will check on what the volunteer departments do for driver training and request records of training. Chairman Farley advised he wanted to also make sure the Ambulance Service and Sheriff's Department had appropriate driver training. Following discussion,

"Commissioner Stevens moved, seconded by Commissioner Young, to approve the County Fire/Rescue report as presented. This motion passed unanimously by acclamation."

There appearing to be no further business to come before the Committee, Chairman Farley declared the meeting adjourned at 6:35 p.m.
