Brian Robertson and Barbara Marlin explained that this project has been several months in getting to this point and is being scored by a nine person panel with four different entities represented: City of Murfreesboro, Town of Smyrna, Consolidated Utility District and Rutherford County. It is scored in four different sections as follows:

Statement of Qualifications	25%
Imagery	25%
Approach	25%
Price	25%

They had sent out a Request for Qualifications to bid on this project and received seven responses back in September which has already been scored. The imagery has already been scored so right now 50% of the scoring is already compiled and has been presented to the Mayor. The nine person panel will now score the approach, the price score will be tabulated based on their ranking, and those will be added to the other two for a recommendation to the Purchasing Committee at its next meeting.

2010 (OR NEWER) FIRE RESCUE TRUCK

Brindlee Mountain Fire Apparatus, Union Grove, AL	\$149,000.00
2010 Deep South/International 4x4 Heavy Rescue	

Fire Chief Larry Farley advised the Committee that this will be a rescue truck for Kittrell Fire Department. Kittrell Fire Chief Ingle had agreed if the County would purchase the truck that they will purchase all of the necessary extrication equipment. The truck will be paid for by a grant from the Christy Houston Foundation in the amount of \$155,000. This truck has only 3,000 miles on it. Chief Farley recommended awarding the bid for this truck. Commissioner Black said he thinks the County is getting a good deal.

“Commissioner Shafer moved, seconded by Commissioner Black, to award the bid to Brindlee Mountain Fire Apparatus for a 2010 Deep South/International 4x4 Heavy Rescue in the amount of \$149,000. The motion passed unanimously.”

There being no further business, Chairman Burgess declared the meeting adjourned at 5:00 p.m.
