
Dear Mr. Gooch:

Three of the seven members who currently serve on the Rutherford County Agricultural Committee have terms which expire at the end of this calendar year. Those with expiring terms are Delia Goodman, Anthony Scales and Joe Frank Jernigan (Commissioners Jernigan was appointed to complete Steve Sandlin's term) By law (CHAPTER 212, HOUSE BILL NO. 789), the three positions must be filled by one farm woman, one farmer, and one county commissioner.

Delia Goodman, Anthony Scales and Commissioner Jernigan are eligible for reappointments. They have been strong supporters and have worked diligently to assist the Extension Staff in their efforts to provide quality educational programs for Rutherford County residents. I hope their desire is to serve for another two-year term which runs from January of 2015 through December of 2016. I would most definitely support a recommendation for their reappointment by the Steering Committee as well as their approval by the County Commission.

Would you assist us by announcing the four position vacancies and (later) recommending a farm woman, a farmer, and one commissioner for appointment to the Agricultural Committee by the County Commission?
